- Advanced Medical Technology: LG Healthcare, Inc. made a strategic decision to equip its Nephro Access centers exclusively with state-of-the-art Nikkiso hemodialysis machines. This investment underscores our commitment to providing reliable, efficient, and effective treatments, ensuring our clinical teams have the best tools to care for our patients.
- A Superior Patient Environment: We believe that the physical environment is integral to a patient's healing and well-being. Therefore, each patient station is designed as a personal haven, featuring a comfortable, fully adjustable recliner chair and a personal television complete with earphones for privacy and entertainment during treatment sessions.
- Guaranteed Physician-Led Supervision: A cornerstone of our operational policy at LG Healthcare, Inc. is the non-negotiable presence of a qualified physician during every treatment session at our Nephro Access facilities. This guarantees the highest level of patient safety and ensures that immediate, expert medical intervention is always available.
- Uncompromising Safety & Infection Control: Our commitment to patient safety is absolute. We have implemented rigorous protocols, including a sophisticated reverse osmosis water filtration system to ensure water purity. Furthermore, we utilize separate, semi-automated reprocessing machines for hepatitis-negative and hepatitis-positive patients to eliminate the risk of cross-contamination and adhere to the highest standards of infection control.

- Pasig Choice Market: This flagship facility operates with 32 advanced Nikkiso hemodialysis machines.
- Malabon Gov. Pascual: Our second center expanded our reach with 16 new Nikkiso machines.

Future Development and Strategic Outlook:

• Pasig – Sandoval (Under Construction): Demonstrating our forward momentum, LG Healthcare, Inc. is currently constructing our third Nephro Access facility, located on the 2nd Floor of the Luckygold Sandoval Bldg. in Pasig City. Upon its launch, this center will add another 32 hemodialysis machines to our capacity, significantly deepening the market penetration of our renal care services and reinforcing our position as a key provider in the region.
